# 2025-2027 Strategic Plan

Embracing our community-led work, CRLA engaged numerous stakeholders in the process to create our three-year strategic plan. Our four plan pillars aim to amplify our local and national reputation, codify our model for community lawyering, and grow and sustain our efforts to create more opportunities to dismantle unjust systems.

#### Over the next 3 years, CRLA will:

#### Pillar 1: Grow to create systemic change, informed by the needs of the community

While our direct service work makes a significant incremental impact, our systemic advocacy and community lawyering efforts play a transformative role in dismantling unjust systems to positively impact entire communities. Both are equally necessary to meet our mission. Our work under Pillar One ensures we can focus on providing clients with the services they need, while also allowing us to hear, learn from, and work alongside the communities we serve to uncover more opportunities to advocate for and impact systemic change. When we achieve Pillar One, we will have implemented a phased organizational growth plan that allows us to reach more people in more communities as well as grow our systemic impact.

#### Pillar 2: Ensure all clients have access to all services regardless of location

Under Pillar Two, we will continue to operate as a statewide organization, leaning into our community-led work, while creating a streamlined organizational structure that allows for manageable workloads and clear expectations for our team. This will include rebranding our field offices to Rural Justice Centers, focusing on delivering services and building trust with populations that share a common identity, and establishing practice areas. We will continue to operate strategic initiatives that support innovation and incubation of projects responsive to the community.

#### Pillar 3: Develop our people to achieve our mission

The communities we serve, our staff, and board members are the heartbeat of CRLA's mission. Pillar Three is dedicated to maintaining a healthy culture, reducing turnover, increasing collaboration across Rural Justice Centers and programs, and boosting engagement of our staff and board.

#### Pillar 4: Create the infrastructure for growth and more impact

Pillar Four is about ensuring we have the infrastructure necessary to continue to grow and operate as a statewide organization. We will launch a capital campaign, which will allow us to solidify or establish a permanent presence in the communities we serve. We will update, upgrade, and align our technology systems to support data gathering, outcomes measurement, and advocacy efforts, and update our processes and systems to create quality experiences for everyone who engages with CRLA – from clients to donors to staff and community members.
